No LeadingAge Policy Updates calls on April 17 and 19, the week of the Leadership Summit. On Monday, April 24, Mark SooHoo, Health Lead at Meteorite and Health Action Alliance will join us to talk about the recent publication, "Three Years of COVID-19: Lessons Learned and Next Steps for Employers." HUD Launches eTool Requirement for Capital Needs Assessments. After several years of delays, HUD has published requirements for using the Capital Needs Assessment (CNA) eTool for Asset Management. The Notice provides guidance on the policy for submission and review of CNAs required for 10-year updates. The Notice applies to Federal Housing Administration (FHA) insured properties, Rental Assistance Demonstration conversions, and several eligible asset management milestones. Starting June 27, 2023, 90 days from the date of publication of the notice, use of the automated CNA eTool is required for all CNA submissions, with a limited number of exceptions identified in the notice. Appropriations Hearings on HUD FY24 Budget. The House and Senate Appropriations Committees will hold their FY24 HUD funding hearings on April 18 and 20, respectively. HUD Webinar: Expiration of COVID-19 Emergency and Impact on HUD-Assisted Residents. Important changes are underway in COVID-related policies, including impacts on health care and on the emergency allotments for Supplemental Nutritional Assistance Program (SNAP). Webinar on Homelessness and Older Adults. The Housing and Services Resource Center of the HHS Administration for Community Living is hosting an April 18, 3 – 4pm ET, webinar on solving homelessness among older adults, people with disabilities, and other populations. Webinar participants will hear from stakeholders from a collaboration in a county with high rates of homelessness and learn about steps that local partners took to begin and sustain their partnership, replicable strategies to create bridges across systems so individuals can have both <u>housing without precondition</u> and access to self-directed or person-centered comprehensive services that they choose, and improvements in housing stability made possible by leveraging each sector's strengths and expertise. Senate Hearing on HUD Nominations. On April 18, the Senate Banking, Housing and Urban Affairs Committee will hold a hearing on two HUD nominees, both of whom were originally nominated by President Biden in 2021 but whose nominations were not advanced because of a partisan stalemate. The hearing will hear testimony from, and consider the nominations of, Solomon Jeffrey Greene to be HUD Assistant Secretary for Policy Development & Research and David Uejio to be HUD Assistant Secretary for Fair Housing and Equal Opportunity. New Learning Hub Resource on Bullying.
